I, **Charles H. Evitt**, of the State of Wyoming, County of Johnson, being of legal age and of sound and disposing mind and memory, hereby revoking all Wills and Codicils previously made by me, do hereby make and publish this, my Last Will and Testament, as follows:

***FIRST***

My wife's name is **Mary Jo Evitt** and she is sometimes referred to herein as "my Wife". I have three daughters from a prior marriage, **Michal Unruh**, **Leslie Hiatt** and **Sandra Evitt**. I have adopted **Krystal Pruzinski**. My four daughters are sometimes referred to herein as "my Daughters"

***SECOND***

I direct that as soon after my death as it is practical to do so, all of my lawful debts, including estate and inheritance taxes and other governmental taxes and charges, including funeral expenses, be paid. The balance of my estate which remains after payment of debts and taxes as stated herein, shall be disposed of as hereinafter provided.

### ***THIRD***

I may prepare a written statement or list of items of tangible personal property, which list shall be dated and shall be in my handwriting or signed by me, and shall include a description of the items and the persons to receive those items with reasonable certainty. I direct that my Personal Representative convey all items on such list to the persons named on the list in accordance with this Section of my Will and Section 2-6-124 of the Wyoming Statutes.

### ***FOURTH***

I do hereby specifically give, devise and bequeath my ranch and associated machinery, tools and livestock located on the ranch, together with all water rights and ditch rights, said land being generally situate in Township 52 North, Range 83 West, 6<sup>th</sup> P.M., all of my said ranch lands consisting of approximately 2,000 acres, together with a state lease, equally, share and share alike unto my Wife, Mary Jo Evitt, and my Daughters, Michal Unruh, Leslie Hiatt, Sandra Evitt and Krystal Pruzinski, provided, however, that they shall survive me by thirty (30) days, or if one or more shall predecease me, then to the survivor or survivors thereof. I do further specifically give, devise and bequeath my mountain property located in Johnson County, Wyoming, and consisting of approximately 1,070 acres, and being generally described as Township 52 North, Range 84 West, 6<sup>th</sup> P.M., Section 1: Lots 1, 2, 3, 4, S $\frac{1}{2}$ N $\frac{1}{2}$  and S $\frac{1}{2}$ ; Section 12: N $\frac{1}{2}$ NE $\frac{1}{4}$ , W $\frac{1}{2}$ NW $\frac{1}{4}$ , SW $\frac{1}{4}$ , W $\frac{1}{2}$ SE $\frac{1}{4}$  equally, share and share alike unto my Wife, Mary Jo Evitt, and my Daughters, Michal Unruh, Leslie Hiatt, Sandra Evitt and

Krystal Pruzinski, provided, however, that they shall survive me by thirty (30) days, or if one or more shall predecease me, then to the survivor or survivors thereof.

***FIFTH***

I do hereby specifically give, devise and bequeath my Merrill Lynch brokerage account unto my Daughters, Sandra Evitt and Leslie Hiatt, provided, however, that they shall survive me by thirty (30) days, or if one shall predecease me, then to the survivor thereof.

***SIXTH***

I do specifically give, devise and bequeath unto my Wife, **Mary Jo Evitt**, provided that she shall survive me by thirty (30) days, the following:

- A. My home and ten (10) acres located at 6611 East Peak View, Cave Creek, Arizona.
- B. All of my bank accounts, savings accounts and checking accounts, after payment of other specific bequests and expenses of administration.
- C. All motor vehicles owned by me at the time of my death.
- D. All stocks, bonds and securities owned by me at the date of my death, not otherwise provided for in Article Fifth.

***SEVENTH***

In the event that I still own properties located at Taos, New Mexico, at the date of my death, I direct that my Personal Representative sell those properties and that the net proceeds

from such sale be divided among those of my seven (7) grandchildren, named hereafter, who survive me by thirty (30) days. Those grandchildren are **Kelly Lawrence, Cory Lawrence, Ryan Lawrence, Jennifer Rockman, Jared Rockman, Danielle Unruh, and Whitney Hiatt.**

***EIGHTH***

I do hereby give, devise and bequeath the sum of \$25,000 to **Stacy Ridley**, provided that she shall survive me by thirty (30) days.

***NINETH***

I specifically give, devise and bequeath all of my tangible personal property unto my Wife, **Mary Jo Evitt**, provided that she shall survive me by thirty (30) days.

***TENTH***

As and for all of the rest, residue and remainder of my property, real, personal, or mixed, of every kind and nature whatsoever, and wherever situated, I give, devise and bequeath the same unto my Daughters, **Michal Unruh, Leslie Hiatt, Sandra Evitt** and **Krystal Pruzinski**, equally, share and share alike, and if one or more of my Daughters shall not survive me, then to her surviving issue, if any, per stirpes.

***ELEVENTH***

I do nominate and appoint my Wife, **Mary Jo Evitt**, and my Daughters, **Leslie Hiatt** and **Sandra Evitt**, as the Personal Representatives of my estate and direct that they be
