STIPULATION FOR DISTRIBUTION OF ESTATE

COME NOW Co-Personal Representatives Leslie Hiatt and Sandra Evitt, two of the duly appointed and acting Personal Representatives of the Estate of Charles H. Kirven, Kirven and Kirven, P.C. and Co-Personal Representative, Mary Jo Evitt, duly appointed and acting Co-Personal Representative of the Estate of Charles H. Goddard, Goddard, Wages, and Vogel, and pursuant to this Court's Order for Sale of Real and Personal Property entered May 27, 2014, do hereby stipulate and agree to the distribution of the estate set forth herein, and represent that said distribution is a good and sufficient means for meeting the elective share of the surviving spouse as provided in said Order, as follows:

1. That the Evitt mountain property be sold and the net proceeds divided fifty percent (50%) to the surviving spouse, Mary Jo Evitt and fifty percent (50%) to the remaining heirs Michal Unruh, Leslie Hiatt, Sandra Evitt and Krystal Pruzinsky.

That the personal property associated with the Evitt ranch, except those items

delineated on the attached Exhibit A, be distributed to the surviving spouse, Mary

4. That the Arizona property be distributed to the surviving spouse, Mary Jo Evitt

upon payment to the remaining heirs of the sum of \$200,000.00. Co-Personal

Representatives Leslie Hiatt and Sandra Evitt agree to relinquish their right to act

with respect to necessary probate proceedings in the State of Arizona, provided

the surviving spouse shall from the date of this stipulation bear the expenses and

costs, including attorney fees, of the Arizona property and its distribution to the

surviving spouse, Mary Jo Evitt. The sum of \$200,000.00 shall be paid upon the

distribution or sale of the Arizona property. If the property is not sold prior to the

sale of other real property of the estate, Mary Jo Evitt shall pay the sum of

\$200,000.00 from her portion of the sale of other real property of the estate on the

date of closing of the sale.

That all of the personal property associated with the Arizona property be set over

and distributed to the surviving spouse, Mary Jo Evitt.

6. That Stacey Ridley be paid the sum of \$25,000.00 as provided in the Last Will and

Testament upon distribution of the Estate.
